# Upcoming fund events Mackenzie Investments



We'd like to let you know about some fund events happening with Mackenzie's simplified prospectus renewal, which we expect to be receipted on or around October 2, 2024.

## **New fund launching in October**

On October 17, Mackenzie will enhance its product line-up with the launch of the Mackenzie US Small Cap Fund.

The fund seeks to provide long-term capital growth by investing primarily in equity securities of small-capitalization companies in the United States and will give investors an opportunity to diversify their US allocation.

# Risk rating changes

Mackenzie is changing the risk rating for following funds:

Mackenzie reviews risk ratings and makes adjustments in accordance with the Risk Classification Methodology mandated by the Canadian Securities Administrators (CSA). There are no changes to the investment strategies of these mutual funds.

# Reminder: low load 2 purchase option funds

As a reminder, Mackenzie stopped selling deferred sales charge (DSC) and low load purchase options in June 2022, and the redemption schedules for low load 2 funds have now expired. If you haven't already terminated these funds on your back-office system, please be sure to do so at your earliest opportunity.
